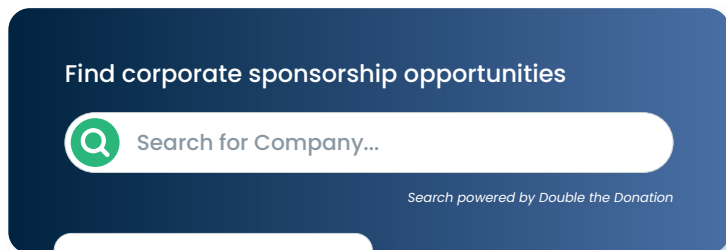
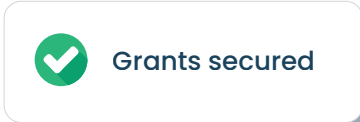
Many volunteer grants go unclaimed because employees and nonprofits don't know who is eligible. Double the Donation helps you turn those eligible hours into dollars.

Payroll giving programs provide reliable long-term support, yet few employees enroll due to a lack of awareness and unclear instructions.

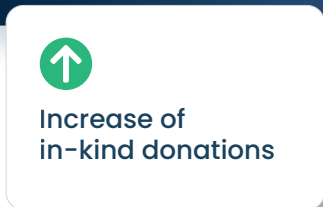
