Della can be trained quickly on new languages, with guidance from local counsel to verify the accuracy of the answers. We've had great success in terms of accuracy so far in many European languages as well as Japanese.

A USE CASE

An Austrian law firm wanted to test how accurate Della could be at reviewing Austrian leases.

The firm put together a list of 77 questions that needed to be answered. They wanted to see whether they could use Della for the following use cases: multi-jurisdictional lease review and reporting, mass document review, contract risk assessment and repapering.

HOW CAN DELLA'S MULTILINGUAL CAPABILITIES BE USED?

M&A Due Diligence

Use Della on multijurisdictional due diligence projects to speed up contract review and detect potential problems early on.

International finance

Summarise long finance agreements in multiple languages and detect if they are compliant with regional policies.

Cross-border deals

TRAINING DELLA IN A NEW LANGUAGE

1. Load your documents

First, you load a document in any language, a lease agreement for example, into the Della Platform.

2. Create your checklist

Then you compile a list of questions that you need the answer to or use a template that Della provides. You can save your template for future use.

3. Analyse your document

You then open the document you want to analyse, select your checklist and let Della work its magic.

4. Reviewing phases

This part is very important when training Della in a new language. You can mark when an answer is correct which helps our AI learn. If an answer is incorrect, you can check through Della's alternative answers or point it in the right direction.

Della usually requires a couple of review phases to reach optimum accuracy level. In our experience, Della needs on average 3 review phases to be trained on a new language.

5. Download your report

Aggregate your analysis and export as a Word document or in Excel as per your needs.
